Auditor General to Review Extractive Industry Revenues

The Auditor General's Office (AGO) is set to gain full access to financial data from the extractive industries as part of a government-led initiative to enhance transparency and accountability. Spearheaded by the Department of Treasury, this effort aims to strengthen oversight of revenues generated from the mining, oil, and gas sectors.

During a recent meeting in Port Moresby, AGO officials and representatives from the Multi-Stakeholder Group (MSG) were introduced to an auditing framework presented by JICA expert Mr. Shiro Otomo. The framework establishes standardized reporting procedures and verification methods to ensure the accuracy of revenue data provided by extractive industry operators.

The review process will officially commence following the signing of a Memorandum of Understanding (MOU) on July 1, which will formalize the AGO's role in assessing financial reports and verifying government earnings from the sector. This initiative is expected to improve financial accountability and reinforce public trust in revenue management.

The Department of Treasury, through the Papua New Guinea Extractive Industries Transparency Initiative (PNGEITI), has been actively promoting transparency in the extractive sector. Since

2013, PNGEITI has published reports analyzing government earnings and sector governance, contributing to improved oversight and policy reforms. The AGO's involvement marks another significant step in ensuring that revenues from the extractive industries are accurately reported and effectively utilized for national development.

AGO Staff Strengthen Ethical Standards in Audit Practice

In a concerted effort to uphold integrity and professionalism, staff of the Auditor General's Office (AGO) recently participated in an ethics training session facilitated by Ms. Rachel Kris, an advisor from the Australian National Audit Office (ANAO). The session was conducted as part of the ongoing partnership between ANAO and the Pacific Association of Supreme Audit Institutions (PASAI) to reinforce ethical practices in public sector auditing.

Ms. Kris emphasized the critical role of integrity in decision-making, highlighting its direct impact on maintaining public trust in audit institutions. She underscored the ethical challenges auditors frequently encounter, particularly regarding the acceptance of gifts and benefits. Drawing from best practices in international audit institutions, she stressed the importance of clear policies, including monetary limits and transparent reporting mechanisms, to mitigate conflicts of interest.

"A proactive approach to preventing ethical breaches is far more effective than addressing them after they occur," Ms. Kris noted, urging AGO staff to remain vigilant in safeguarding the credibility of their work.

The training also explored personal and professional dilemmas auditors may face, particularly in maintaining professional boundaries in their interactions with clients. Through interactive discussions and shared experiences, AGO staff reaffirmed their commitment to ethical conduct, further strengthening the institution's dedication to accountability and transparency.

The AGO continues to prioritize professional development initiatives to enhance its role in promoting good governance and public financial management in Papua New Guinea.




As part of the broader International Women's Day agenda, AGO and PASAI reaffirmed their commitment to championing gender equity and supporting women at all levels of professional growth.
